If you make less than about \$49,000 and have children at home, the Earned Income Tax Credit and Child Tax Credit can reduce the income tax you pay and may even mean a much bigger tax refund – as much as \$5,000 or more! Plus there are tax credits that can help you pay for college.

2 Maneras muy fáciles de hacer que la temporada de impuestos le pague:

1. Asegúrese de reclamar todos los créditos que le corresponden.

Si usted gana menos de US \$ 49,000 y tiene hijos en casa, el Crédito por Ingreso del Trabajo y Crédito Tributario por Hijo pueden reducir el impuesto sobre la renta que usted debe pagar y puede incluso significar una devolución de impuestos mucho más grande — hasta \$ 5,000 o más! Además, hay créditos fiscales que pueden ayudar a pagar la universidad.

(Para reclamar el EITC se requiere un número válido de Seguro Social de los padres y los niños. Para el Crédito Tributario por Hijos, los trabajadores y los niños deben tener un número válido de Seguro Social o ITIN).

2. Obtenga su declaración de impuestos gratis.

Visite los sitios de ayuda para los Impuestos en Colorado y obtenga su declaración de impuestos preparada y llenada electrónicamente por estudiantes universitarios certificados por el IRS de forma gratuita. Los servicios son gratuitos para los contribuyentes con ingreso familiar inferior a \$49,000.

Visit the Tax Help Colorado sites and get your tax return prepared and e-filed for free by IRS-certified college students. Services are free to taxpayers with household income less than \$49,000.

Make sure to bring the following documents with you to the tax site:

- ✓ All W-2s, 1099s and any other income-related documents.
 - ✓ Proof of mortgage interest, property taxes, daycare payments, charitable contributions and all other tax-deductible expenses.
 - ✓ For college expenses: In addition to Form 1098T from your college, it is important to bring your own records of expenses paid for tuition, books, fees and supplies.
 - ✓ Social Security Cards (or ITINs) for all family members. Photo I.D.
 - ✓ A copy of last year's tax return, if available.
 - ✓ Bank account number and routing number to direct deposit your refund. With direct deposit, refunds are received in just 7-10 days!

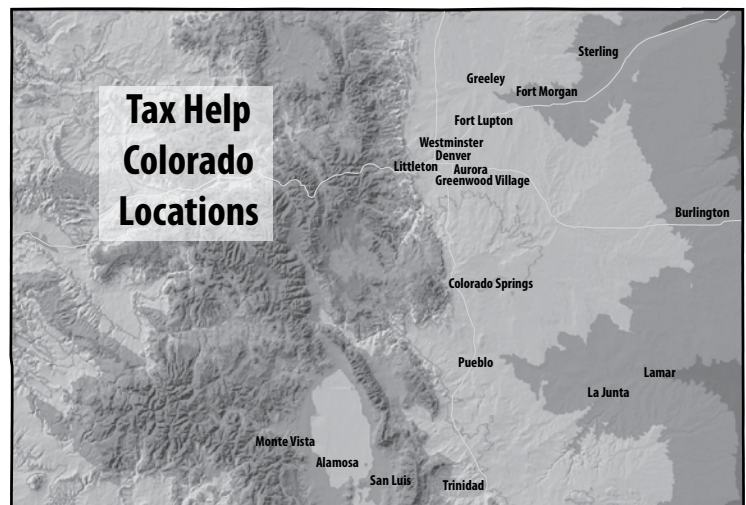
